Eligibility

The South Australian Nursing and Midwifery Excellence Awards are open to South Australian nurses and midwives from all healthcare sectors and settings.

To be eligible for nomination, a nurse or midwife must:

- > Be working either full-time, part-time or casually as a nurse or midwife (or in a nursing/midwifery-related role) at the time of nomination.
- Hold a practising certificate with the Nursing and Midwifery Board of Australia (NMBA) and have no conditions or undertakings on their registration.
- Not be the subject of any employer performance management or disciplinary processes.

Conditions of entry

- You cannot self-nominate for an Excellence Award.
- Nominations from previous years can be resubmitted for consideration.
- > Previous award winners will not be eligible for nomination for three years following the receipt of their award.

Judging

- An independent committee will consider the evidence for all nominations in accordance with the award category criteria and provide a shortlist to the judging panels for adjudication.
- > A judging panel comprising representatives from the public, private, aged care, nongovernment, community and the education sector will assess the nominations.
- All decisions of the judging panel are final, and it is not a requirement of the judging panel to provide feedback to nominees.
- If two finalists cannot be split by the judging panel, the Chief Nurse and Midwifery Officer, SA Health will select the winner.

1. Choose your category

2. Write your nomination

Nominations should be written in a style that is clear, easy to understand and avoids jargon.

Please ensure you address each question in the nomination. Provide objective examples to support your claim and consider the information that may be most relevant to the judging panel.

3. Submit your entry

All entries must be submitted via the online nomination portal available at sanursingandmidwiferyexcellenceawards.com.au

You will need to create a login and follow the steps to complete your nomination.

Entries will close 22 December 2023.

What happens next?

Judging

Nominations will be shortlisted by an independent committee, which will assess how closely each nomination meets the set category criteria.

Shortlisted nominations will then be provided to an independent judging panel for adjudication.

The judging panel comprises nursing and midwifery representatives from the public, private, aged care, community and non-government, industrial and education sectors in South Australia.

Nominees will be notified via email in early February 2024 if they have been selected as a finalist.

Short films

If you are selected as a finalist, SA Health will produce a short film about your nomination to visually demonstrate its value and impact.

The film will be approximately one minute in length and finalists will have the opportunity to speak on camera, record voice-overs, and choose locations and overlays for inclusion in their film.

The film will be debuted at the Excellence Awards Gala Dinner, and all finalists will receive a copy of their film after the event.

Excellence Awards Gala Dinner

Winners will be announced at the Excellence Awards Gala Dinner, to be held on Friday 3 May 2024 at the Adelaide Convention Centre.

All finalists will receive a complimentary ticket to the dinner, and friends, colleagues and family can purchase tickets at a discounted rate.

Tickets for the Excellence Awards Gala Dinner will go on sale in March 2024.

This award recognises the outstanding performance of an individual nurse or nursing team working in a residential aged care facility, community aged care program or inpatient unit.

This nominee delivers an exemplary standard of practice and is committed to providing evidenced-based and person-centred care to older people.

Award requirements:

Individual or Team Award

Assessment criteria:

- Explain how the nominee demonstrates skill, commitment, resourcefulness and/or innovation in their practice (150 words max).
- 2. Explain how the nominee delivers responsive and person-centred care to older people (150 words max).
- 3. Explain how the nominee positively empowers and supports others (150 words max).
- Explain how the nominee influences sustained improvements in service delivery and/or outcomes (150 words max).

Individual or Team Award

Assessment criteria:

- Explain how the nominee develops educational opportunities (either clinical or non-clinical) to meet the learning needs of the nursing and midwifery workforce (200 words max).
- 2. Explain how the nominee positively empowers and supports others through nursing and midwifery education (200 words max).
- Explain how the nominee uses education and learning activities to influence sustained improvements in service delivery and/or outcomes (200 words max).

Award requirements:

Team Award

The nominated team must contain two or more nurses or midwives. All team members (eg. administrative or ancillary staff) are recognised in this award.

Assessment criteria:

- Explain how the nominee demonstrates skill, commitment, resourcefulness and/or innovation in their practice (150 words max).
- 2. Explain how this nominee delivers responsive and person-centred care (150 words max).
- 3. Explain how the nominee positively empowers and supports others (150 words max).
- Explain how the nominee influences sustained improvements in service delivery and outcomes (150 words max).

- Explain how the nominee's research activities or innovation influences sustained improvements in service delivery and outcomes (200 words max).

- Explain how the nominee's leadership influences sustained improvements in service delivery, patient outcomes and/or clinical practice (200 words max).

- Explain how this nominee has contributed to delivering positive outcomes to patient care and experience (200 words max).
- 3. Explain what makes this nominee stand out from their peers (200 words max).
